

Position Purpose:

Performs complex professional and management work in providing daily administration of Town operations. Acts as the Chief Administrative Officer for the Board of Selectmen and carries out the orders and policies of the Board of Selectmen in accordance with all laws and Town rules, regulations, ordinances, policies and procedures. Performs all other related work as required.

Essential Functions:

(The essential functions or duties listed below are intended only as illustrations of the various types of work that may be performed. The omission of specific statements of duties does not exclude them from the position if the work is similar, related or a logical assignment to the position.)

- Administers the daily operations of the Selectmen's office.
- Creates and implements policies of the Board of Selectmen. Acts as liaison for the Board of Selectmen with counsel, professional affiliates, state departments, employees and the public.
- Oversees and trains the staffing of the Board of Selectmen Business Office to include assessing, finance, land use, Human Resources and personnel. Reviews and critiques all work performed for the Board of Selectmen's office.
- Oversees and assists the Department Heads with any/all duties requiring assistance.
- Responsible for financial reporting, balancing, preparation, budgets, benefits and annual audits.
- Prepares and schedules the Board of Selectmen's agendas, oversees proper minutes prepared, posted and archived with the town Clerk.
- Responsible to direct and inform the Selectmen within the state laws and town policies.
- Serves as an intermediary with all Department Heads. Coordinates with elected and appointed officials and town commissions and boards not under his/her supervision.
- Attends all regular and special meetings and hearings of the Board of Selectmen and has the responsibility of providing backup and analytical information as needed.
- Recommends to the Board for adoption, such measures requiring action by them as he/she may deem necessary or expedient.
- Maintains a full and complete inventory of all property of the town, both real and personal.
- Responsible for overview of purchases of supplies, material and equipment for all departments and activities of the town, and makes recommendations to the Board of Selectmen.
- Works in concert with the Board and other appropriate parties to complete grant applications for submission to other authorities on behalf of the town.
- Responsible for the fiscal area of operations to include cash flow, method of accounting, budget submission and budget control.
- Maintains personnel files and records. Attends to training needs of employees; motivates and coaches staff. Advises Selectmen on personnel matters and on all matters affecting Town employees and volunteers. Ensures uniform application of the personnel policies and performance evaluations of the Town. Manages Town insurance and employee benefit programs.
- Administers purchasing policies. Coordinates Town purchases, including reviewing purchase requisitions, drafting specifications, preparing bid documents, and evaluating competitive bids received.
- Attends all meetings of the Board of Selectmen and other meetings as required by the Board; responsible for setting the agenda and the accuracy of records of all Board of Selectmen

meetings; represents the Selectmen whenever they are unavailable, and acts as their representative. Prepares press releases and reports. Handles Selectmen's correspondence. Makes appointments for Selectmen. Performs project administration.

- Performs similar or related work as required, directed or as situation dictates.

Recommended Minimum Qualifications:**Education, Training and Experience:**

Bachelor's degree in Public Administration, Business Administration, or related field plus five years' administrative and municipal management experience; or any equivalent combination of education and experience.

Knowledge, Ability and Skill:

Knowledge: Extensive knowledge of local government operations, administration and management practices and procedures; knowledge of the application of state and federal laws and policies which affect local government, including purchasing; knowledge of fiscal management and planning and human resource management.

Ability: Ability to plan, organize and direct the preparation of reports, analyze problems, and formulate recommendations. Ability to speak and write effectively. Ability to establish and maintain effective working relationships with all town employees, board/committee members, officials and the public. Ability to recognize town-wide priorities and work cooperatively to support their accomplishment. Ability to exercise judgment and discretion in applying and interpreting the policies of the Board of Selectmen. Ability to prioritize multiple tasks and to maintain confidentiality and demonstrate ethics, integrity and tact.

Skill: Proficient fiscal skills. Demonstrated skills in working cooperatively with other agencies, citizen groups, and individuals in promoting the best delivery of services to the community. Excellent managerial, organizational and communication skills. Proficient in utilizing contemporary office applications for word processing, database, spreadsheet, presentation, municipal finance software, Assessing data base and internet use.

Physical Requirements:

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

Regularly required to walk, stand, sit, talk, and hear; operate objects, tools, or controls; pick up paper, files and other common office objects. Ability to view computer screens and work with details for extended periods of time. May move objects weighing up to 10 pounds. Must be able to communicate.

Supervision:

Supervision Scope: Performs complex and highly responsible duties, requiring the exercise of a high level of independent judgment in providing professional advice to the Board of Selectmen and town officials, departments, boards and committees concerning the development,

implementation and administration of the policies, goals, regulations, and statutory requirements related to the administration and operation of the town.

Supervision Received: Works under the policy direction of the Board of Selectmen with considerable latitude for independent judgment and initiative. Questions are referred to supervisor only when clarification of town policy is needed.

Supervision Given: Supervises Town Department Heads and Town office staff.

Job Environment:

- Most work is performed in office conditions; regular schedule requires attendance evening meetings; additional time is required to prepare for meetings and other events.
- Operates a computer, telephone, and other standard office equipment.
- Performance of duties requires regular contact with town residents, town employees, state and federal officials, business and community organizations, consultants, and vendors.
- The employee has access to all town-wide confidential information, including bid proposals, personnel records, agreements, and legal proceedings.
- Errors in judgment and administration could have a continuing adverse effect on the town's ability to deliver services, and result in monetary loss and legal repercussions.
